## County Supervisors Schedule Public Hearing Concerning Future of Recycling Center

### Residents urged to give their input on possible closing

**CUSTER COUNTY CHIEF - BROKEN BOW, NE** - At the December 24, 2018, Custer County Supervisors meeting, the board discussed closing the Recycling Center, located on the west edge of Broken Bow, due to cost.

Concerned citizens are worried about what may happen if the center is closed, including illegal burning, illegal dumping and illegal burying as well as the increased impact on the landfill.

If you want the center to re-

main open to accepting recyclable goods (plastic, aluminum, cardboard), you are encouraged to let your supervisor know.

Attend the Public Hearing at 10:45 a.m. on Tuesday, March 12, 2019 in the third floor Supervisor’s Meeting Room at the Custer County Courthouse in Broken Bow.

You can also contact your supervisor to let them know that you support and use the recycling center and you want it to stay open.

The Supervisors were sched-

uled to tour the Recycling Center at 11:30 a.m., Tuesday, Feb. 26.

## Rialto Theatre Upgrades Speaker System

### \$3,500 project funded by grant, donations

Through a grant and generous donations, the Arnold Rialto Theatre has installed an additional two front speakers. These speakers pick up additional sounds in the movie that were not available with the former number of speakers. The cost of the project was \$3,500.00.

Funding came from the Custer County Foundation (\$1,000.00), Sandhills Open Road Challenge (SORC) (\$1,000.00), the Sheldon and Jean Wenquist Family Endowment Fund administered by the Custer County Foundation (\$1,000.00), and the Elizabeth Elliott Memorial (\$500.00).

“The Custer County Foundation is excited to award a grant to the Arnold Community Theater for new speakers. The Rialto provides a great service to Arnold, and we are happy to assist through our grants program,” said CCF Executive Director Lindsay Divan.

Rialto Board President Mary Becker explained that Wisconsin resident Dorothy Wenquist, daughter of Sheldon and Jean, coordinates with the Foundation twice a year to identify projects throughout Custer County. She and her siblings chose the Rialto Theatre’s speaker upgrade as one of their beneficiaries.

“Bob Westbrook was a big

help in the early stages of the upgrade by providing consultation, and then later by wiring the speakers and helping with the installation. Community support is always appreciated,” said Mary.

The Rialto Theatre Board is continually working to provide a comfortable environment for movie patrons and volunteers. With the upgraded speaker system completed, the Board is now considering a couple of new projects, including finding a way for hard of hearing movie goers to enjoy the movies, and finding a way to heat the lobby during the cold winter months and keep it cool in the hot days of summer.

The Board invites folks to come to the movies, which are shown on Friday and Saturday at 7:00 p.m., and Sunday at 5:00 p.m.
