More Filings Received for Local Boards

The Custer County Clerk's office reports that two more filings for local boards were received by the non-incumbent deadline of March 1 since *The Sentinel's* last report.

Shane Cool has filed for a position on the Arnold School Board. Previous filings were made by incumbent Joseph Cool and non-incumbent Merle Bierman for the three open positions.

Non-incumbent Gary Larreau filed for a position on the Arnold Hospital Board. None of the three members whose terms are up filed by the incumbent deadline.

South Loup Competing at State Tourney

After drawing a wild card, the South Loup boys basketball team is playing at the state tournament today (Thursday, March 8) at Lincoln Southeast High School. The Bobcats, seated #6 with a 21-3 record, are playing #3 seated Hastings St. Cecilia (22-3). The winner of that game will play either #2 Yutan (24-1) or #7 Arcadia-Loup City (22-4), March 9 at the Devaney Sports Center.

The championship game will be played March 10 at the Pinnacle Bank Arena. The third place game will be played March 10 at Lincoln East.

Equipment Failure Forces Rialto to Cancel Showings


The showing of "Paddington 2" at the Rialto Theatre was cancelled last weekend and again this weekend due to equipment failure. It is believed that a power surge that occurred on Saturday, February 24, damaged the projector. Rialto Theatre Board President Mary Becker said that upon inspection, the IT person deemed the projector a total loss.

The projector is covered by insurance, and Becker has spoken with both the insurance agent and an adjuster. Hopefully, the decision of whether or not insurance will replace it will be made quickly.

Becker said last Friday that the showing of "Hostiles," starting on March 16-17-18, will be possible, but there are no guarantees. "Paddington 2" is paid for, so if the projector can be replaced, it can be shown in the future.
