## Custer County Foundation Seeks Donations for Flood Relief Fund

Custer County experienced a devastating flood on March 13th causing widespread damage throughout the county and state. Preliminary numbers are estimating the loss to Custer County at \$4.71 million, public, and \$3 million, private. In response to the devastation, the Custer County Foundation established a flood relief fund to assist Custer County residents. The Custer County Foundation is seeking monetary donations to assist individuals that experienced loss due to the flooding. All donations received by the Foundation will be distributed back, 100%, to Custer County residents. Custer County residents seeking assistance will need to fill out an application and schedule an appointment with Central Nebraska Community Action Partnership (CNCAP). Assistance is available for both housing and certain agricultural losses. Because of IRS Classifications that govern the Custer County Foundation, it is partnering with CNCAP to assist with the relief efforts to individuals. CNCAP has the organizational capacity and expertise to serve individuals. office 308-872-2232. To schedule an appointment with CNCAP, contact Tiffany Foley 308-872-6013. Assistance will be distributed on a first come first serve basis.

Two Speech Team Members Medal at State Speech Meet, Cool Earns Gold

Proud parents, siblings, friends, coaches and administrators, but most of all two very proud Humorous Prose speakers, finished the 2019 season with top honors. Buttons were popping everywhere as Arnold’s two State Speech contenders Tatum Cool and Layla Rivera saved their best performances for the state meet held at Kearney on Friday, March 22.

In a tough round of 18 District D1 finalists, the girls came through their first two rounds by placing in the top six. Judges ballots were read and discussed as the two prepared for their finals round. In speech, it’s always interesting to see how the judges’ comments can vary tremendously and present extremely opposite views. For the judges, analyzing competitors’ performance comes down to the items listed on the rubric: voice quality, distinction between characters, use of the performance area, interpreting the authors intent, and above all in Humorous, making the audience laugh. Both girls mastered the last item! It was such a relief to hear the judges chuckling, and in some cases, they even stopped writing. (You know they’re enjoying the performance when that happens.) Layla has astounded her coaches all season by performing and medaling in three different events; Duet, OID, and

her state-placing event Humorous Prose. Third place at the district meet in North Platte meant she was state bound. Since this is Layla’s first year of speech, she’ll be around the next three years to entertain the folks in Arnold.

Senior Tatum Cool finished her high school speech season in GRAND style earning the top honor, the gold medal in Humorous Prose. Not only that, Tatum had received the first place medal in every meet of the 2019 season. She’s a “team” player, because she stepped up to help her team as a substitute, in both OIDs, at different times during the season.

Both young ladies started the 2019 Speech Season strong and never looked back, improving with every performance. For them, it was an amazing year.
